## **Notice of Public Information Meeting for** **the Port Jefferson to Wading River** **Rails to Trails Project**

**An “Open House” Public Information Meeting will be held on March 15, 2018 from 6:00 PM to 8:00 PM at the Miller Place High School, located at 15 Memorial Drive, Miller Place, NY 11764, to present the above referenced project.**

The Suffolk County Department of Public Works is in the final design stage of a project to construct a 10 foot wide asphalt shared-use path within a ten (10) mile long abandoned Long Island Rail Road right-of-way presently owned by the Long Island Power Authority (LIPA), which utilizes it as an electrical distribution right-of-way.

The project area comprises seven hamlets in the Town of Brookhaven, including Port Jefferson Station, Mount Sinai, Miller Place, Sound Beach, Rocky Point, Shoreham and East Shoreham as well as approximately 1,500 feet in Wading River in the Town of Riverhead. The LIPA right-of-way runs in the east-west direction and parallel to Route 25A approximately 300 to 500 feet to the north.

## **Aviso público para session informativa del** **Proyecto “Rails to Trails” de senderos a vías De** **Port Jefferson a Wading River**

Una sesión abierta al público se realizará el 15 de Marzo, 2018 de 6:00 PM a 8:00 PM en el colegio de secundaria de Miller Place localizado en 15 Memorial Drive, Miller Place, NY 11764, para presentar el Proyecto mencionado anteriormente.

El Condado de Suffolk, el departamento de servicios públicos, se encuentra en la etapa final de diseño para construir una vía asfaltada de 10 pies (3m) de ancho para uso múltiple en 10 millas (16 km) de propiedad de LIPA (Compañía de energía de Long Island). Dichas vías fueron reservadas para usos ferroviarios y ahora se encuentran en abandono.

El Proyecto abarca 7 poblados en el distrito de Brookhaven, incluyendo Port Jefferson Station, Mount Sinai, Miller Place, Sound Beach, Rocky Point, el Este de Shoreham y Shoreham. Asimismo alrededor de 1,500 pies (457 m) en Wading River en el distrito de Riverhead. La propiedad reservada de LIPA esta orientada en la dirección este-oeste y paralela a unos 300 a 500 pies (90 a 152 m) de distancia al norte de la Ruta 25A.
