*****GPS DIRECTIONS*****

Use **725 Veterans Highway, Smithtown, NY 11787** for GPS to get you to the Suffolk County Offices. See map on reverse to get you to Bldg. #C016.

HEADING WEST:

FROM THE LIE

- Take the LIE to Exit 57 (Rt. 454).
- Turn right at the 1st light on Rt. 454 West.
- Proceed on Rt. 454 for approximately 1.5 miles.
- Stay left on Rt. 454 when the road splits with Rt. 347 (by the Paradise Diner). Immediately move to the right lane.
- You will pass a tall office building on the left (H.Lee Dennison Bldg.) & the entrance to Blydenburgh County Park on the right.
- You will see 2 signs... one that says "Suffolk County Offices" and another sign that says "County Center Rd".
- Make the next right (at the traffic light)
- The 4th Police Precinct is on the corner.
- Follow instructions below to Bldg #C016.

Proceed to Building #C016

- After turning into the complex by the 4th Precinct, head straight up the hill.
- You will pass a white building on the left & the Gas Pumps on your right.
- The road will sharply curve left.
- When you get to the end of the long, red brick building, make the 1st left.
- Then make a quick right in front of the trailer that says "EAC Suffolk TASC".
- The 1st left will take you into a parking lot in the courtyard of the short brick building #C016.
- Park in this courtyard & proceed to the entrance in the back right corner.

HEADING EAST:

FROM THE LIE

- Take the LIE to Exit 55.
- Take the 1st left over the LIE (Motor Pkwy). Stay in the far right lane.
- Immediately turn right onto Old Willets Path (sign says Rt. 6).
- Stay straight on Old Willets Path for approximately 1 mile.
- After you pass a sign for "The Lakes" on your left, you will come to an intersection with Rt. 454 (Veterans Highway).
- Go straight & make a right at the next traffic light (North Drive).
- Follow instructions below to Bldg #C016.

FROM NORTHERN STATE PARKWAY

- Take Northern State Parkway all the way to the end.
- Merge onto Rt. 454/347 East.
- Quickly move to the left lane.
- Turn left on Old Willets Path.
- Make a right at the next traffic light (North Drive).
- Follow instructions below to Bldg #C016.

Proceed to Building #C016

- After turning onto North Drive, make the 2nd right (brown sign for Medical Examiner/Probation on the corner).
- Immediately turn left in front of a gray trailer.
- Make the 1st right into the courtyard of Bldg #C016 (one story, brick building).
- Park in this courtyard & proceed to the entrance in the back right corner.
