Internet Printing

In order to participate in Internet Printing, you must have an IPP-enabled printer on your network configured to accept port 9100 (preferred) or 631. It is recommended that you use a Dynamic DNS host name in lieu of your IP address, as your IP address is likely to change from time to time. Popular Dynamic DNS hosts include <http://www.dyndns.com> and <http://www.no-ip.com>. Exceptions can be made for those departments who subscribe to a static IP Internet service.

Alternatively, SCFRES accepts IPP-enabled printers published through Microsoft IIS. Your IT staff must provide a URL for printer installation at SCFRES. Contact SCFRES for further information.

It is also possible to print to multiple destinations, i.e. - printer in the chief's office and the garage floor. Those printers MUST be identical and either be configured using separate ports or published through IIS (preferred). Contact SCFRES for further information.
