## **CONTRIBUTION LIMITATIONS**

### **STATE OFFICE CONTRIBUTION LIMITS**

### **CONSTITUTED COMMITTEES ONLY**

#### **(TOWN & COUNTY)**

*For any and all constituted committees in Suffolk County (this includes the committees for each of the ten towns: Babylon, Brookhaven, East Hampton, Huntington, Islip, Riverhead, Shelter Island, Smithtown, Southampton and Southold), the contribution limitation, the amount that any constituted committee may receive from an individual in a calendar year is \$109,600. This amount is for individual contributions only and does not apply to corporate contributions.*

#### **HOUSEKEEPING**

*There are no limits on contributions to a Constituted committee for Housekeeping expenses. ONLY Constituted committees may have a Housekeeping fund for maintaining a headquarters.*

#### **CORPORATIONS**

*Political contributions made by Corporations may NOT exceed \$5,000 in a calendar year. This is an aggregate amount for any and all political contributions made by that corporation within the State of New York and does not override the contribution limitations that the various candidates and committees can receive.*
