

Green Key Card Information

A Green Key card entitles the holder access to Suffolk County Parks at reduced fees for park activities. The Green Key card is required to access the online reservation system for, camping and marina reservations. Green Keys are good for three years from the date of purchase, unless otherwise specified. Discounted Green Keys are available with the appropriate certifications and/or proofs.

Residency Proofs:

Residency proof is required for any Resident Green Key card. Name and address should match on all proofs.

Below are the accepted residency proofs.

Primary Proof: (1 required)

- New York State Driver's License or New York State issued Non-Driver Photo Identification Card
- New York State Pistol Permit

Secondary Proof: (1 required with match address to primary, 2 required if address does not match primary proof)

- Green Key Card – not expired more than 2 years
- Property Tax Bill from a town in Suffolk County.
 - Date must be within six (6) months (6 months passed last bill or 6 months prior to new bill).
- Property Deed with a Suffolk County street address
- Current Lease or Rental Agreement
- Motor Vehicle Registration with valid expiration with Suffolk County address.
- Auto Insurance ID Card with valid expiration with Suffolk County address.
- Phone or credit card bill showing service to address and must be less than six (6) months old.
- Utility bill showing service to address and must be less than six (6) months old.
- Mortgage Statement less than six (6) months old, showing Suffolk County address.
- Bank Statement must be less than six (6) months old showing Suffolk County address.
- Township Recreation Card with valid expiration.
- Library Card or Voter Registration Card, must not be expired.
- NYS Marina Permit or NYS Fishing License, must not be expired.
- High School I.D. Card must cover current year.
- Suffolk County Employee ID Card

Discounted Green Proofs:

Discounted Green Keys require additional proof. Failure to provide discounted proof may result in suspension of Green Key and or account. Below are the required discounted proofs for Discounted Green Keys based on type of discount.

Senior Citizen (60+ years old, as of date of sale)

- Date of birth on New York State Driver's License, Birth Certificate etc.

Junior (17 or under years old, as of date of sale)

- Date of birth on New York State Driver's License, Birth Certificate etc.

Handicap (1 required with residency proof)

- Suffolk County Handicapped Services ID Card (Yellow)
- New York State Handicapped Access ID Card (Blue)

Volunteer (1 required with residency proof)

- Fire Department/EMS ID Card with valid expiration date
- Typed Letter on department Letterhead stating "ACTIVE" and "VOLUNTEER" with a current date (may be no more than 6 months old)
- Suffolk County Police ID, must say "AUXILIARY" with valid expiration date

Veteran (1 required with residency proof)

- DD-214 form
- Suffolk County Veteran Resident ID Card (SCVR ID) – issued by Suffolk County Veterans Agency.
- Driver's license with Veteran indication

Disabled Veteran (1 required with residency proof)

- Red, White, and Blue Veterans Administration ID Card from DVA, with photo saying "SERVICE CONNECTED" underneath.
- Letter confirming service connected injury

Active Military (both with residency proof)

- Standard orders of mobilization
- Military ID

To expedite your discounted Green Key Renewal, you can submit Proof Documents online.

3. Click **Submit Documents**
4. Select **Person** in household to link document to.
5. Enter brief description of file (ex. Volunteer Proof)
6. Select a **Document Category**
7. Click **Choose File** button and select file
8. Click **Upload** button
9. File will be updated to your account and notification email sent to the Parks Administration Office for review.
