b) Security Fire Protection Services, Inc.

Complaint received 9/22/20 naming Security Fire Protection Services, Inc. The location is Bergen Point Golf Course, Maintenance Building, 69 Bergen Avenue, West Babylon, NY 11704. *M. Matteo is questioning the manufacturer date of the extinguishers, as it is not clear in the pictures and not stated in the complaint. If the date is not clear, the Board needs more information in order to make a decision. J. Kuethen, the complainant, made a new picture available for the Board indicating the extinguisher is a Badger with a manufacturer date of 2008. In light of this new evidence, which will be submitted via email, motion was made to send a Letter to Appear made by D. Lynch and seconded by A. Duspiva. J. Kuethen abstained from voting, 10/15/20 J. Canino reported that he went to the location and rectified the problem. He submitted photographs documenting that the extinguisher was replaced. Motion that he submit a letter of retraining to the Board made by M. Matteo and seconded by A. Duspiva.*
