**RESOLUTION 48-2013, CONCERNING A SEQRA DETERMINATION FOR THE PURPOSES OF CHAPTER 450 OF THE SUFFOLK COUNTY CODE FOR THE 2014 VECTOR CONTROL PLAN OF WORK**

**WHEREAS**, at its October 16, 2013 meeting, the Suffolk County Council on Environmental Quality reviewed the EAF and associated information submitted by the Suffolk County Department of Public Works, Division of Vector Control; and

**WHEREAS**, a presentation regarding the proposal was given at the meeting by Dominick Ninivaggi, Superintendent with the Suffolk County Department of Public Works, Division of Vector Control; and

**WHEREAS**, the action involves the implementation of the 2014 Vector Control Annual Plan of Work by the Suffolk County Department of Public Works, Division of Vector Control to control mosquito infestations that significantly threaten public health, or create social or economic problems to the communities in which they occur. To achieve this goal, the Division employs an integrated control program. Control measures are employed in a hierarchical manner that emphasizes prevention. Control first proceeds from surveillance and more permanent "environmentally friendly" measures such as water management and biological control, then through the highly specific larvicides and finally, uses chemicals such as adulticides only after other measures prove to be either insufficient or not feasible. This integrated approach is recognized as the most effective and environmentally sound manner in which to conduct a mosquito control program. Only pesticides that are federally and NYS registered and approved for mosquito control will be used. All machine work within existing mosquito ditches for the purpose of eliminating mosquito breeding areas that involves BMPs 4 and above will be reviewed by the Suffolk County Office of Ecology within the Department of Health Services, the Council on Environmental Quality and the Department of Economic Development and Planning and approved by the N.Y.S.D.E.C. in order to minimize environmental impacts on wetlands; and

**WHEREAS**, Suffolk County Resolution No. 285-2007 adopted the Suffolk County Vector Control and Wetlands Management Long Term Plan and State Environmental Quality Review Act Findings Statement for the Final Generic Environmental Impact Statement; now, therefore, be it;

**RESOLVED**, that based on the information received, a quorum of the Council recommends to the Suffolk County Legislature and County Executive, pursuant to Chapter 279 of the Suffolk County Code, that the proposed 2014 Vector Control Annual Plan of Work will be carried out in conformance with the conditions and thresholds established for such actions as set forth in the Suffolk County Vector Control & Wetlands Management Long Term Plan Final Generic Environmental Impact Statement (FGEIS) and associated Finding Statement as adopted by Suffolk County. Therefore, no further SEQRA compliance is required pursuant to Title 6 NYCRR Part 617.10(d)(1) and the Legislature and County Executive should adopt a resolution stating as such.

Mr. Martin noted that there are no updates on the custodial agreements and none of the pending contracts have been completed since the Council's last meeting. The Parks Department is working with the County Attorney's office to see if the contract process can be simplified.

**Recommended Unlisted Actions:**

- A. Proposed Replacement of CR16 Bridge over LIRR and LI Avenue, CP5855, Town of Brookhaven

Paul McMahon, Principal Civil Engineer with the Suffolk County Department of Public Works and Ken Holmstrom, Project Manager from LIRO Engineers gave a presentation regarding the project which involves the full replacement of the bridge carrying CR 16, Horseblock Road over the LIRR and LI Avenue. Bridge is over 70 years old and in the last four years they have had two emergency deck repairs. It is an 80 percent federally funded project and is scheduled for construction 2015.

Mr. Kaufman made a motion to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. Ms. Growney seconded the motion. Motion Carried.

B. Proposed Interchange Improvements for CR111 at LIE, CP5123, Town of Brookhaven

Paul McMahon, Principal Civil Engineer with the Suffolk County Department of Public Works and Ken Holmstrom, Project Manager from LIRO Engineers gave a presentation regarding the project which involves the design for the interchange improvements for CR111 at the Long Island Expressway.

Mr. Swanson made a motion to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. Ms. Spencer seconded the motion. Motion Carried.

C. Proposed Pedestrian Safety Improvements on CR 35, Park Avenue, Town of Huntington

Jeff Dawson, Senior Civil Engineer, Suffolk County Department of Public Works and Kevin Papasian of FST Engineering gave a presentation regarding the Pedestrian Safety Improvements on CR35 Park Avenue. Mr. Dawson noted that the intent of the project was to provide a safe continuous walkway within the corridor.

Joy Squires proposed to table this project. Ms. Squires mentioned that she believed that the Town of Huntington had not yet seen this project and she proposes that the Town of Huntington be given additional time to review and properly respond to the project. Lauretta Fischer, Principal Environmental Analyst for the Suffolk County Department of Economic Development and Division of Planning & Environment gave a presentation regarding the acquisition of 4.79± acres of land by Suffolk County for open space preservation purposes.

Mr. Kaufman made a motion to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. Ms. Growney seconded the motion. Motion Carried.

- E. Proposed Acquisition of Property by Suffolk County (80%) and the Town of Brookhaven (20%) for Open Space Preservation Purposes Known as the Westhampton II Old Country Senior Housing, LLC Property – Topping Path, Town of Brookhaven

Lauretta Fischer, Principal Environmental Analyst for the Suffolk County Department of Economic Development and Division of Planning & Environment gave a presentation regarding the acquisition of 4.00± acres of land by Suffolk County for open space preservation purposes.

Mr. Kaufman made a motion to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. Ms. Growney seconded the motion. Motion Carried.

- F. Proposed Sewer District No. 3 Southwest, Electrical Substation Protection, CP 8170, Town of Babylon

Ben Wright, Principal Engineer for the Suffolk County Department of Public Works, gave a presentation regarding providing flood protection for the Sewer District #3 Southwest's electrical substation. Mr. Wright noted that this substation is the heart of the Southwest Sewer District and everything that operates at this system is powered by this substation. It was not damaged during any of the previous storms but they want to make sure that it has the proper protection for the future.

Mr. Kaufman made a motion to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. Ms. Growney seconded the motion. Motion Carried.

- G. Proposed Sewer District No. 3 Southwest, Pumping Stations No. 9 & 10, CP 8181, Town of Babylon

Ben Wright, Principal Engineer for the Suffolk County Department of Public Works, gave a presentation regarding building modifications to Pumping Stations No. 9 & 10 to provide increased flood protection. These two pumping stations experienced water damage from previous storms. Flood protection measures are to be taken to prevent future flooding.

Ms. Growney made a motion to recommend classification of the proposed project as an Unlisted Action with a Negative Declaration. Mr. Pichney seconded the motion. Motion Carried.

Some of the current generators are older than fifteen years which is older than the FEMA recommended age for emergency generators. This project will help insure that the sewer districts have working generators when the County is impacted by storms.

B. Vector Control 2014 Annual Plan of Work

Dominick Ninivaggi, Superintendent, Suffolk County Department of Public Works, Division of Vector Control made a presentation regarding the annual plan for the County's ongoing mosquito control program.

Mr. Ninivaggi noted that this work plan for 2014 is essentially the same as last year's plan. A short form EAF was completed to that effect. Mr. Ninivaggi noted that pesticide usage including the use of larvacide this year was down. Mr. Ninivaggi also stated that this year the Vector Control Division will continue with wetland maintenance type activities and are awaiting the final approval of the Wetlands Management Plan so that some higher level wetlands management projects can be completed.

The CEQ also noted that a Supplemental Environmental Impact Statement is required because this change may have significant environmental impacts and the change has not been addressed in the Long Term Plan's Final Generic Impact Statement.
