I. ORDER OF BUSINESS

Call to Order

Sarah Lansdale called the meeting of the Suffolk County Farmland Committee (“Committee”) to order at 6:10 pm at the Kermit W. Graf Cornell Cooperative Extension Building, 1st Floor Conference Room, 423 Griffing Avenue, Suite 100, Riverhead, New York 11901.

Approval of Minutes – November 25, 2014

A motion was put forth by Howard Johnson, and seconded by Albert Schmitt, to approve the minutes of the November 25, 2014 meeting of the Committee, as outlined in Committee Resolution FC-3-2015. Motion carried: 16-0-0 [See Exhibit “A” for Committee Resolution FC-3-2015]

Approval of Minutes – January 20, 2015

A motion was put forth by Howard Johnson, and seconded by Albert Schmitt, to approve the minutes of the January 20, 2015 meeting of the Committee, as outlined in Committee Resolution FC-4-2015. Motion carried: 16-0-0 [See Exhibit “B” for Committee Resolution FC-4-2015]

Introduction of Jason Smagin of the Suffolk County Department of Law

Robert Braun introduced Jason Smagin, Assistant County Attorney for the Suffolk County Department of Law, as a new County staff member who will be attending Committee meetings.

Correspondence –

Lauretta Fischer read a letter from Chairman Sarah Lansdale appointing Ms. Fischer to serve as the Chairperson of the Committee and voting member on those occasions that Ms. Lansdale is unable to attend a Committee meeting, as permitted under SC Code Chapter 8, Section 8-4D(3).

Lauretta Fischer read a letter from Jeffrey L. Bragman, Attorney for the Fonseca family, in which he requested the Farmland Committee to refrain from recommending the initiation of litigation, and provided background to reassure the Committee that the Fonseca family has acted diligently and in good faith to resolve the matter through settlement rather than litigation.

The applicant seeks a Special Use Permit for the installation and maintenance of a drainage structure, in association with a commercial agricultural operation. The land has been excavated and soil was removed from the premises prior to submission of this application. (Application No. 2012025)

Ms. Fischer advised the Committee of staff's recommendation for the Committee to put forth a resolution stating a deadline of March 3, 2015 for receiving a remediation plan application, or the Committee is granting permission by this resolution for the County to move forward with litigation.

Bob Braun advised the Committee that it is the intent of staff's recommendation to receive an application and remediation plan by March 3rd. Further, if a good faith effort is made at submitting an application and remediation plan, the Law Department can be instructed to wait on commencing litigation. If on the other hand, the County does not receive an application and remediation plan, the Law Department can move forward on the recommendation of staff. A discussion ensued.

A motion was put forth by August Ruckdeschel and seconded by Howard Johnson, to approve and issue a resolution in accordance with staff's recommendation stating that there will be no more postponements for submitting a remediation plan application to the County and the deadline for receiving an application will be March 3, 2015, or the Committee is granting permission by this resolution for the County to move forward with litigation. Motion carried: 16-0-0 [See Exhibit "D" for Committee Resolution FC-6-2015]

A. RALPH AND CATHERINE CASELNOVA

Main Road (S.R. 25), Orient, Town of Southold
Tax Map #: 1000-018.00-03.00-009.009 (11.3 ± acres)

The applicant seeks an Agricultural Development Permit for the installation and maintenance of an agricultural storage shed, concrete pad and deer fencing, in association with an agricultural operation. (Application No. 2015001)

Ms. Fischer presented the Staff Report.

Committee members commented that a considerable portion of the property did not appear to be in commercial agricultural production based on the 2013 aerial photo provided by staff. Staff advised the Committee that a letter would be sent to the landowner advising that the property must be in commercial agricultural production and not lay fallow for more than two consecutive years pursuant to Chapter 8 requirements. Further, a Committee member noted

that there appeared to be ATV tracks on the property. Staff advised that a comment could be added to the aforementioned letter regarding potential ATV usage, which is strictly prohibited on County PDR land.

A motion was put forth by Alfred J. Kilb, Jr., and seconded by Charles F. Scheer, Jr., to adopt the Staff Report for Application No. 2015001, as amended, and to approve the Agricultural Development requests, as outlined in Committee Resolution FC-7-2015. Motion Carried: 16-0-0 [See Exhibit "E" for Committee Resolution FC-7-2015].

B. PAULETTE SATUR AND EBERHARD MUELLER / "SATUR FARMS"

The applicant seeks an Agricultural Development Permit for the installation and maintenance of deer fencing, in association with a commercial agricultural operation. (Application No. 2015002)

Ms. Fischer presented the Staff Report.

A motion was put forth by Charles F. Scheer, Jr., and seconded by Howard Johnson, to adopt the Staff Report for Application No. 2015002, as amended, and to approve the Agricultural Development request, as outlined in Committee Resolution FC-8-2015. Motion Carried: 16-0-0 [See Exhibit "F" for Committee Resolution FC-8-2015].

C. ANRI DEVELOPMENT GROUP, LLC

Barnes Road, Moriches, Town of Brookhaven

Tax Map # 0200-751.00-02.00-005.000 and 0200-781.00-01.00-001.006 (36.5 ± acres)

The applicant seeks an Agricultural Development Permit for the installation and maintenance of greenhouse infrastructure, in association with a proposed change of use to a commercial mushroom farm. (Application No. 2015003)

Ms. Fischer presented the Staff Report.

Robert Braun advised the Committee that in 2007 when the County and Town of Brookhaven purchased the development rights to the four former Jurgielewicz Duck Farm parcels (SCTM#s 0200-751.00-02.00-005.000, 0200-788.00-01.00-001.006, 0200-750.00-07.00-001.000 and 0200-788.00-01.00-001.005) there was 105,000 square feet of lot coverage over the four parcels, as described in the Deed of Development Rights. A stipulation in the Deed of Development Rights allowed for a maximum lot coverage of 205,000 square feet or 10.32% on all four lots.

The current application proposes 11.125% lot coverage for existing and proposed structures on the two lots owned by Anri Development Group, LLC (SCTM #s 0200-751.00-02.00-005.000 and 0200-788.00-01.00-001.006) and would thus exceed the 10.32% maximum lot coverage allowed by the Deed.

According to Chapter 8 of the Suffolk County Code, a maximum lot coverage of 12.5% would be allowed for the two lots owned by Anri Development Group, LLC.

If the Town of Brookhaven accepts the requirements of Chapter 8 of the Suffolk County Code, as it now exists, and may be amended, in the future, to all four former Jurgielewicz Duck Farm properties, and in so doing, abandons the specific requirement in the Deed of Development Rights that restricts the four former Jurgielewicz Duck Farm parcels to a maximum lot coverage of 205,000 square feet for existing and proposed structures, then the following recommendation is presented to the Committee:

An Agricultural Development Permit will be issued if the following conditions have been met:

- 1) The Town of Brookhaven shall accept and approve, by letter or resolution, the requirements of Chapter 8 of the Suffolk County Code, as it now exists and may be amended in the future, to the four former Jurgielewicz Duck Farm properties including the property of which Anri Development Group LLC owns two parcels, and to abandon the specific requirement in the Deed of Development Rights that restricts the four former Jurgielewicz Duck Farm parcels to a maximum lot coverage of 205,000 square feet for existing and proposed structures; and
- 2) Letters shall be provided from all three current owners of the four former Jurgielewicz Duck Farm properties of which Anri Development Group LLC owns two parcels, consenting to all requirements of Chapter 8 of the Suffolk County Code, as it now exists and may be amended in the future, and abandoning the specific requirement in the Deed of Development Rights that restricts the four former Jurgielewicz Duck Farm parcels to a maximum lot coverage of 205,000 square feet; and
- 3) The landowner of the two Anri Development Group LLC parcels consents that neither parcel shall be sold to another owner without prior Suffolk County Farmland Committee approval.

A motion was put forth by Howard Johnson., and seconded by Rob Nolan, to adopt the Staff Report for Application No. 2015002, as amended, and to approve the Agricultural Development Permit request subject to meeting certain conditions, as outlined in Committee Resolution FC-9-2015. Motion Carried: 15-0-1 [See Exhibit "G" for Committee Resolution FC-9-2015].

V. OTHER BUSINESS

Introduction of Vincent Biondo, a potential new Committee Member

Sarah Lansdale introduced Vincent Biondo of the Town of Babylon who is anticipated to be appointed as a Committee Member to replace sitting Committee Member Ann Marie Jones. (Mr. Biondo would be officially appointed once a resolution is received from the Babylon Town Board confirming his appointment.)

VI. EXECUTIVE SESSION

A motion was put forth by Howard Johnson and seconded by Sarah Lansdale to move into Executive Session to discuss the Ruth Pollio Revocable Trust property. Motion Carried: 16-0-0.

VII. OTHER BUSINESS (Continued)

Ruth Pollio Revocable Trust property (Tax Map # 1000-108.00-01.00-001.001)

Committee members discussed the work plan for the compost remediation project on the subject property, as attached to the Order on Consent (File # R1-20110420-51).

The Committee recommended accepting the work plan, as approved by NYS DEC, as revised and dated February 9, 2015, along with the signed Order on Consent (File # R1-20110420-51). Upon completion of the remediation steps outlined in the work plan, the County must receive notification that the work has been completed and will inspect the property to determine whether all materials have been removed, and if not removed, may be subject to further fines and remediation as determined by the Committee. Further, the Committee recommended that any trees, shrubs, saplings and other volunteer weed growth that has grown on any portion of the PDR property must be removed in addition to the removal of materials described in the work plan. By October 1, 2015 the entire PDR property must be plowed under with a cover crop planting of rye or similar crop at 2 ½ bushels of rye or similar crop per acre. If this has not been completed as of October 1, 2015 a fine of \$10,000 will be imposed and thereafter a \$1,000 fine per month will be imposed until this requirement is completed.

A motion was put forth by Howard Johnson, and seconded by Nate Corwin to accept the aforementioned work plan and additional requirements, as outlined in Committee Resolution FC-10-2015. Motion Carried: 16-0-0 [See Exhibit "H" for Committee Resolution FC-10-2015].

Committee affirmed existing permit application deadline

The Committee affirmed that all complete applications must be received by the Suffolk County Division of Planning and Environment by no later than two (2) weeks before the scheduled Suffolk County Farmland Committee Meeting dates.

A motion was put forth by Howard Johnson, and seconded by Russell K. Barnett to affirm the Committee application deadline, as outlined in Committee Resolution FC-11-2015. Motion Carried: 16-0-0 [See Exhibit "I" for Committee Resolution FC-11-2015].

Applicant Proposal to construct a barn on PDR

John Kennedy introduced Vito Strippoli who is proposing to construct a barn on his PDR property. Bob Braun instructed Mr. Strippoli to contact Laretta Fischer to fill out an application for consideration at the next meeting.
